Estimation of The Environmental Value of Recycled Wood Wastes: A Conjoint Analysis Study

ABSTRACT

The purpose of this paper is to estimate the environmental value of recycled wood wastes using conjoint analysis. A comparison of the pair-wise rating method and the choice experiment elicitation method is made. An empirical study of recycled water-cleaning filters made from wood wastes shows that recycling has significant value as estimated by both pair-wise rating and choice experiments. However, the estimated marginal willingness to pay for recycling differs somewhat between the two methods. It may be that profile design effects appear in our survey.

1. INTRODUCTION

In Japan, many people are interested in recycling. Public opinion polls show that 74% of respondents think that increasing consumption of resources is one factor contributing to global environmental problems, and 45% of respondents are trying to use recycled goods to conserve the environment (The Prime Minister's Office, 1995).

The purpose of this paper is to estimate the environmental value of recycled wood wastes using conjoint analysis. Conjoint analysis is one of many multi-attribute preferenceelicitation techniques widely used in market research. Environmental economists have recently begun to employ conjoint analysis.

In section 2, the theoretical background of conjoint analysis is discussed. Conjoint analysis has many elicitation formats including pair-wise rating and choice experiments. Section 3 presents the economic model of the demand for recycled goods and methods of valuation. Section 4 presents the empirical results of the study of recycled water cleaner filters estimated by pair-wise rating and choice experiments. Finally, section 5 provides the conclusion.

2. CONJOINT ANALYSIS

Recycled goods have many attributes. For example, the attributes of paper products include its color, thickness, weight, price, materials, and so on. The environmental value of recycled paper is also one of the attributes of paper products. Though the market price of paper reflects the values of all its attributes, it is difficult to quantify the environmental value from the price of paper.

Table 1 shows an overview of stated preference elicitation methods. In the field of environmental economics, contingent valuation (CV) has traditionally been used to estimate the value of environmental resources (Carson et al., 1995). CV asks respondents' willingness to pay or willingness to accept compensation for the environmental change in question. CV evaluates both the use value and the non-use value (passive use value) of single-attribute environmental goods. However, the value of each attribute cannot be distinguished using CV in a multi-attribute environmental good. Therefore some economists have recently begun to pay attention to conjoint analysis as a new valuation technique that can identify the value of each attribute that makes up the multi-attribute environmental good.

TABLE 1. Stated Preference Approach and Conjoint Analysis

Conjoint analysis is a multi-attribute preference-elicitation technique widely used in marketing research, transportation, and psychometrics (Green and Srinvasan, 1978, 1990; Louviere, 1988 and 1994; Wittink and Cattin, 1989; Wittink, Vriens, and Burhenne, 1994; Green, Krieger and Schaffer, 1993; Carroll and Green, 1995). Conjoint analysis uses profiles which are bundles of attributes. For example, when evaluating preference for paper, respondents are given several profile cards, each of which shows a unique paper product composed of specific attributes, such as color, thickness, weight, price, materials, and so on. A rating-based conjoint asks respondents for their preference of profiles on a rating scale, whereas a choice experiment (sometimes called a choice-based-conjoint) asks respondents to choose their most preferred profile.

Previous conjoint analysis studies for environmental valuation include Viscusi et al. (1991, health risk; pair-comparison), Mackenzi (1993, hunting; pair-wise RBC), Opranch et al. (1993, hazardous waste; pair-wise RBC), Adamowicz et al. (1994, recreation; CE), Johnson and Desvousges (1997, electronic site; pair-wise RBC), Griner and Faber (1996a, b, water resource; pair-wise RBC), Boxall et al. (1996, hunting; CE), Roe et al. (1996, salmon-fishing; RBC), Adamowicz et al. (1997, hunting; CE), Kuriyama (1998, wetland ecosystem; CE) and Adamowicz et al. (1995; 1998, habitat protection; CE).

3. ECONOMIC MODEL

3.1 Rating-Based Conjoint (Pair-wise Rating)

Rating-based conjoint analysis asks respondents to indicate their preferences for profiles using a rating scale. Pair-wise rating, which shows a trade-off of two profile cards, is the most popular elicitation method among environmental economists. Pair-wise rating asks respondents which profile they prefer on a rating scale. For example, the rating scale may be from 1 to 9, where 1 means the respondent strongly prefers the left profile, 9 means they strongly prefer the right profile, and 5 means they are indifferent between the two profiles. Figure 1 shows an example of a pair-wise rating questionnaire.

Johnson and Desvousges (1997) propose an ordered probit model to analyze pair-wise rating data¹. Assume that the individual indirect utility function is represented by the following

random utility model:

where U_j is the total utility that the individual receives from profile *j*, \mathbf{x}_j is the vector of attributes of profile *j*, q_j is the environmental quality of the profile *j*, p_j is the price of profile *j*, V_j is the observable component of the total utility, and ? *j* is the unobservable component. When asked, the pair-wise format is the trade-off between profile *j* and *k*, and the utility difference between the two profiles is

where $\varepsilon_{jk} = \varepsilon_j - \varepsilon_k$ is the difference in the unobservable components. When the indirect utility function is a linear function of attributes, the utility difference is

where β is a vector of attribute parameters, β_q is the marginal utility of environmental quality, and β_p is the marginal utility of money.

Though we cannot observe the utility (U_{ik}) or utility difference (dU_{jk}) directly, we have discrete rating data related to the utility difference. Johnson and Desvousges (1997) use an ordered probit model which assumes the error term, ε_{jk} , in equation (3) is distributed as a standard normal distribution, N(0,1). Figure 2 describes the ordered probit model. When the discrete rating category is between 1 and 9, there are 8 threshold parameters². Then the probability of observing response r_{jk} for the trade-off between profile *j* and *k* is

where Φ is the cumulative standard normal distribution function, α_s are threshold parameters. α_0 is normalized at $-\infty$ and α_9 at $+\infty$.

3.2 Choice Experiment (Choice-Based Conjoint)

A choice experiment (choice-based-conjoint), developed by Louviere and Woodwarth (1983), asks respondents to choose their most preferred profile. Figure 3 shows an example of a choice experiment questionnaire.

Assume that the utility function is the random utility model (1). Then the probability, P(j;C), that the alternative, *j*, is chosen from choice set C (=1,2,...m) is

where $\tilde{\epsilon}_k = \epsilon_k - \epsilon_j$ is the error difference, Ω is the covariance matrix, and $f(\bullet)$ is the joint density of the error differences.

McFadden (1974) showed that if the error terms in equation (5) are independently and identically distributed with a type I extreme-value distribution (a Gumbel distribution), then the choice probability, P_i , has the following closed-form representation,

where λ is the scale parameter, conventionally normalized to 1. McFadden's model is known as the conditional logit model.

3.3 Estimation of Marginal Willingness to Pay

Consider the following utility function, which contains only main effects:

where β is the set of parameters estimated by the ordered probit model for pair-wise rating and by the conditional logit model for the choice experiment. The total differential of the utility function, V, is as follows:

Assume that all attributes except for environmental quality are unchanged ($dx_i=0$) and utility is assumed to be held constant (dV=0). Then, the marginal willingness to pay (MWTP), which is the monetary measure for 1 unit change in environmental quality, is as follows:

4. EMPIRICAL STUDY

4.1 Survey Design of Recycled Water Cleaners

This empirical study estimates the value of recycled water cleaners using pair-wise rating and choice experiments. Water cleaners have many attributes, including their cleaning performance, replacement time, materials, size, color, and price. Existing water-cleaning filters use propylene or polyethylene, which are made from petroleum resources. These filters become waste after being replaced. Another type of water-cleaning filter is being developed, known as a "recycled filter", which is made from construction industry wood wastes and logs from thinning. This recycled filter can subsequently be dissolved by bacteria.

Table 2. Attributes List

Table 2 shows the attributes considered in our survey. Cleaning performance, replacement time, and price are data from existing water-cleaning filters. The associated questionnaire is composed of four parts: (1) an explanation of the difference between normal water-cleaning filters and recycled filters, (2) a question concerning the importance of the attributes, (3) 10 pair-wise rating questions, and (4) 10 choice experiment questions. We used both pair-wise rating and choice experiments. Figure 4 and 5, respectively, show an example of pair-wise rating and choice experiments in the questionnaire for water-cleaning filters.

After two pilot surveys using a small sample, we made a final survey of the general public in Sapporo, Japan on October 1997. The survey was conducted as an in-person interview. A sample of people randomly selected from the telephone directory was interviewed. 200 agreed to participate in this survey, and 163 respondents answered the elicited questions. The average interview time was 15 minutes.

After an explanation of the attributes, respondents were asked to rate the importance of each attribute on a 1-9 gray-scale rating, namely, where 1 was extremely important and 9 was not important at all. Table 3 shows the ratio of respondents who chose 1 or 2. While the most important attribute of water-cleaning filters is their ability to clean trihalomethane, recycling isn't important in comparison with other attributes.

4.2 Estimation Results

Table 4 shows the pair-wise rating results estimated by the ordered probit model. Parameters ? 1 to ? 8 are constant thresholds of discrete choice. All variables except for 'smells of mold' are statistically significant at the 1% level. McFadden's pseudo R^2 is 0.150. Table 5 shows the choice experiment results estimated by the conditional logit model. All variables except for 'smells of chlorine' are statistically significant at the 1% level. McFadden's pseudo R^2 is 0.220, which means the fit of the conditional logit model for the choice experiment data is better than the fit of the ordered probit model for the pair-wise rating data.

Table 6 shows the marginal willingness to pay (MWTP) for each attribute calculated by (9). MWTP_{PW} is the marginal willingness to pay from pair-wise rating data, and MWTP_{CE} is the marginal willingness to pay from choice experiment data. The 95% confidence intervals of MWTPs are calculated by Krinsky and Robb (1986) in a procedure that utilizes 4,000 repeated random draws of the coefficient vectors from the covariance matrix. Removing trihalomethane has the highest value in both pair-wise rating and choice experiments, but for removing trihalomethane the MWTP_{PW} is two times higher than the MWTP_{CE}. The value of recycling as estimated by pair-wise rating (MWTP_{PW}) is 5,244 yen, and by choice experiments (MWTP_{CE}) is 997 yen.

From the data on respondents' stated importance of the attributes in Table 3, the

importance ratio of trihalomethane is highest and the importance of recycling is lowest. The $MWTP_{PW}$ and the $MWTP_{CE}$ of trihalomethane are consistent with stated importance. However, the $MWTP_{PW}$ of recycled filters, which has the second highest value (5,244 yen), is not consistent, so it may be overestimated.

Elrod, Louviere, and Davey (1992) and Oliphant et al. (1992) compared results of rating based conjoint and choice experiments and they showed that both led to estimated results that were comparatively similar in value. Our results, however, show that there is a significant difference between pair-wise rating and choice experiments, and the value of recycling estimated by pair-wise rating may be overestimated. One reason for the difference between the two elicitation methods has to do with sequential effects. Some CV studies have shown that the order of questions affects how respondents evaluate willingness to pay, known as a sequential effect (Boyle et al., 1993). In our survey, respondents were asked questions related to choice experiments after pair-wise rating, and this order of questions may be the cause of the differences in the results obtained from the two techniques.

Another reason for the difference between the two techniques may result from the effects of the profile design. Conjoint analysis uses multi-attributed profiles, and profile design may affect the estimated willingness to pay for attributes. There are large numbers of total possible combinations of attributes, so many researchers have proposed efficient profile designs that reduce this number without affecting estimation (for example, Huber and Zwerina, 1996). Table 7 shows the effects of profile design in our survey. Our survey used 10 profiles for each of the pair-wise rating and choice experiments respectively. FULL means the estimated WTP using all 10 profiles, and #1 means using 9 profiles removing profile #1. When removing #4, #5, or #7 profiles of pair-wise rating, the estimated parameters were not significant. The standard deviation of WTPs in pair-wise rating is larger than in choice experiments. This means that the effects of profile design on pair-wise rating are stronger than on choice experiments in our study.

5. DISCUSSION

Our results show that recycling goods has significant value, as estimated by both pairwise rating and by choice experiments. However, the estimated marginal willingness to pay for recycling differs somewhat between pair-wise rating and choice experiments. In our study, the value of recycling as estimated by pair-wise rating is not consistent with the stated importance of recycling, and it might be overestimated. It may be, however, that a sequential effect and a profile design effect appeared in our survey.

Conjoint analysis can estimate the value of multi-attribute goods, so conjoint analysis is suitable for evaluating recycled goods that have many attributes. However, conjoint analysis, like contingent valuation, uses stated preference data. Thus, the problems of bias that are already recognized in contingent valuation may also appear in estimates of values using conjoint analysis. Furthermore, profile design may affect the estimated willingness to pay. A future study will check the effects of biases and test the reliability of the willingness to pay as estimated by conjoint analysis.

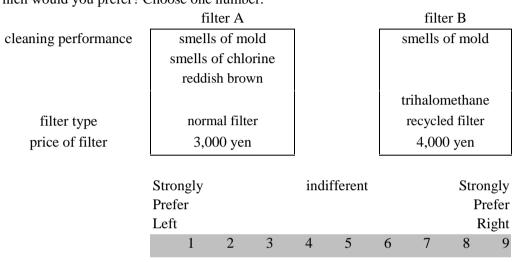


Figure 3. Pair-wise Rating Question for Water-cleaning Filters
